

# **Frequently Asked Questions**

### 1. Do I have to be available for all sessions as outlined in the timetable?

You need to be able to attend at least one meeting with your Director of Finance before the conference, and you must be able to attend the conference in person. The coffee roulette is optional, and the virtual welcome meeting will be recorded. But we would strongly encourage applicants to take part in all of the events scheduled as part of this bursary funding. When at conference you will be expected to attend all the planned events on Wednesday, Thursday and Friday.

#### 2. Do I or my organisation make arrangements/ pay for my travel to London?

NHS England are funding your place at Conference which includes overnight accommodation, and all meals as part of the conference programme. You should discuss with your line manager the process for reclaiming or arranging travel costs. If train travel your organisation may require you to arrange and reclaim, or may be able to book for you and provide you with the tickets. Discuss this with your line manager or Director of Finance as part of your 1:1.

#### 3. What information will I need to provide if I am successful in my application?

HFMA will need to know your HFMA membership number, any dietary requirements or additional requirements such as an accessible room. You will provide these to HFMA only once your application has been approved.

#### 4. Do I need to be a HFMA member?

Yes, there is an expectation that this bursary is only made to HFMA <u>members</u>. However if you are working in a Band 2 - 6 role you can apply to become a member for free <u>here</u>.
